

## MATCH PROGRAM

### 2009 NICOLET RIFLE CLUB HIGH POWER RIFLE MATCHES - 80 ROUND

**SPONSOR:** The Nicolet Rifle Club, Inc.

**MATCH DIRECTOR:** Rick Jerry

**DATES:** Sunday, May 24, June 14, August 23, and September 20, 2009.

**DIRECTIONS:** Take U.S. Highway 41-141 North of Green Bay to Brown County Trunk "B" (Exit 176, Sunset Beach Rd. , Suamico Exit, [New Zoo], etc.). This is approximately five (5) miles North of Tower Drive (Interstate 43) Exit onto County Trunk "B" and head West on "B" (left at the stop sign and pass under Hwy 41-141). You will come to a four-way stop at the intersection of County Trunks "B" and "HS", also known as the intersection of Sunset Beach [or School] Rd. and Velp Ave. Continue West on "B" for 9/10 mile, just past the Suamico Elementary School (on your left), and turn left onto Riverside Drive. The turn is before you cross the railroad tracks. Proceed South on Riverside Dr. for 3/10 mile to the intersection with St. Pat's Drive. (It comes from the right, only). Turn right onto St. Pat's Dr. (West) and proceed, crossing the tracks, for 9/10 mile. The range is in the woods, on the right, just before the road curves sharply left. For those with GPS, our gate is located at N44°38.062" W88°05.314".

**COMPETITION:** Competition is open to the public.

**ENTRY FEE:** \$16.00 per match, Juniors & Seniors \$8.00. Make check or money order payable to Nicolet Rifle Club, Inc., and return, with your name, address, NRA number & classification to:

**ENTRIES CLOSE:** Entries close when range capacity is filled. (Eighty [80] Competitors). **PRE-REGISTRATION AND PREPAYMENT ARE REQUIRED!!!** See details immediately above. **All competitors must be present prior to the start of the first relay, for squadding purposes.**

**FIRING STARTS:** Firing will commence firing at 9:00 a.m. CENTRAL time. The second relay will commence firing at 11:00 a.m. **ANY PREREGISTERED ENTRANT WHO DOES NOT SHOW TO CLAIM HIS POSITION AT LEAST FIFTEEN (15) MINUTES BEFORE SCHEDULED FIRING TIME SHALL FORFEIT HIS RESERVATION FOR THAT POINT.** If said entrant does not show or call at all during the day's relays, **no further pre-registrations will be accepted from him.**

**RULES:** Current NRA HIGH POWER Rifle rules will apply. These matches are covered by NRA rules 3.1, 3.1.1, 3.1.2, 3.1.3, 3.1.4, 3.1.5, 3.1.6 and 3.3. The first four rules apply to service rifles, Caliber .30 M1 (Garand), Caliber 7.62mm M-14, and Caliber 5.56mm M-16 series respectively, and their commercial equivalents, capable of semiautomatic fire ONLY, with no external modifications, except those specifically allowed in the rules (See rule 3.1.3 for the exceptions allowed by AR 920-30.) Rule 3.1.4 addresses "Foreign Service Rifles," Rule 3.1.5 applies to "As Issued M-1 Garand" rifles, and Rule 3.1.6 applies to U.S. Rifle, Caliber 7.62mm M-110 series as issued by the U.S. Armed Forces, or the same type And caliber of commercially procured rifle **without bipod**, (see the 2009 NRA High Power Rules for further allowances and/or restrictions to this type of rifle.) Rule 3.3 applies to N.R.A. Match Rifle - "A centerfire rifle with metallic sights and a magazine capable of holding not less than five rounds. The service rifle may be used, (as described in NRA Rules 3.1, 3.1.1 and 3.1.2) as applies to trigger pull. Any semiautomatic rifle modified for use as an NRA match rifle must conform to NRA Rule 3.14 for use in the standing position. The 20-round box magazine may only be used in the kneeling, sitting and prone positions. Note 1: The use of the 20-round box magazine in the standing position is permitted with M-14 rifles used as NRA Match Rifles, provided that the only modification made is replacement sights. Note 2: Any further modification to the exterior of the rifle such as a different stock, barrel dimensions, integral flash hider, require rifle to be used without the 20-round magazine in the standing position. A shorter box magazine may be used, provided that it conforms to with Rule 3.14. **Any rifle/sight competition may be used, but NOT FOR AWARD.**  
" Any alibi found to be caused by competitor inexperience or error will be disallowed. NRA CHAMBER FLAGS ARE MANDATORY! IF YOU DO NOT HAVE ONE, YOU MUST PURCHASE ONE FROM THE STATISTICAL OFFICER PRIOR TO COMMENCEMENT OF FIRING ON YOUR RELAY. EYE PROTECTION IS MANDATORY! CONTACT LENSES DO NOT QUALIFY AS EYE PROTECTION. **Absolutely NO AUDIBLE timing devices!**

**MATCH SCHEDULE:** These are NRA Matches;  
Match Number 1 is NRA Rule 7.16, 200 Yard regional Match Course.  
20 Shots in 20 minutes, Standing Slowfire Target SR  
2-strings of 10 shots in 60 seconds, Sitting, rapid fire Target SR  
2-strings of 10 shots in 70 seconds, Prone, rapid fire Target SR-42  
20 Shots in 20 minutes, Prone Slowfire Target MR-52  
100-Shots, Total. (Excluding sighters).

Match Number 2 is NRA Rule 7.16; 100-yard Regional Course; In the interests of safety, unclassified, novice, or juniors firing as juniors will be required to fire the 100-yard Course. It is exactly the same course of fire, except for the distance and targets. The targets will be SR-1 for standing and sitting, SR-21 for rapid prone, and MR-31 for Slowfire prone. COMPETITORS WILL SCORE AND RUN TARGETS. The only exception is disabled competitors.  
Five minutes unlimited sighters, any position prior to Standing Slowfire, ONLY!

**CLASSIFICATION:**

NRA High Power Rifle (conventional) classification will be in effect.

**AWARDS:**

An award will be presented for the highest score fired, (match winner). An award will also be made for first place in each class with three (3) or more competitors, and an additional award per each additional five (5) entries in a class after the first three (3). If there is only one Master or High Master, he or she will be eligible for the Match Winner Award only. The one award and out rule will apply! NRA Award Points will be awarded in all cases.

**GENERAL INFORMATION:**

Pre-registration must be made by mail. The range phone number is (920) 434-4946, but you may not reach someone at the range except on match days and before or immediately after each relay. The other phone has an answering machine, so if necessary, please leave a message, and we will get back to you. Those with the earliest postmarks and/or phone calls will be given preference. Those who wait until the last minute may be disappointed. If you cannot make your reservation, please call or tell someone who will be there to inform us so we can re-assign your position. Thank you. ***In many cases, it is much easier to use the e-mail address listed below.***

**LATE ADDITIONS:**

1. No targets may be removed until scores are entered on score cards and cards have been signed by both the scorer and the competitor, in all places indicated!
2. Use of scoring plugs is restricted to range operating personnel (RULE 14.3.1), specifically, Match Director, Statistical Officer, and Executive Officer. ***Use of scoring plugs by anyone else is prohibited and may result in disqualification of the parties involved.***
3. There shall be no smoking allowed forward of the ready line, including the range control room.
4. Only competitors and range officers are allowed on the firing line. The only exceptions are coaches allowed for junior shooters only.
5. Failure to completely fill out and sign SR-1 card ***MAY*** result in disqualification of the competitor.
6. The use of any rifle employing the "BOSS" system will ***NOT*** be allowed as, the noise and blast are disruptive to other competitors. NRA HIGH POWER Rifle Rules do ***NOT*** allow the use of muzzle brakes which is one of the functions the "BOSS" system serves. NRA RULE 3.16.1 - Compensators and Muzzle Brakes- "The use of compensators and muzzle brakes is prohibited".
